The waste sorting labels meet a wide range of requirements from distributors of packaging

What are the waste sorting labels?

A free, cross-manufacturer packaging logo to educate consumers for better waste separation: the waste sorting labels show at a glance how to correctly separate and dispose of the respective packaging.

Why uniform waste sorting labels for packaging?

The Conference of German Environment Ministers has recognised an urgent need for action in view of the insufficient quantities of collected packaging waste: Distributors should provide uniform labels on packaging to increase consumer awareness. Also, according to a survey conducted by YouGov, 85 percent of consumers want uniform waste sorting labels on packaging.

Do the logos by Trennhinweis e.V. work?

The labels demonstrably help consumers to dispose of packaging correctly. And they do so clearly: on average, consumers dispose of packaging labelled with the logos by Trennhinweis e.V. correctly almost twice as often as packaging without the symbol.

How can the logos be used?

The logos can be used free of charge by companies that are registered with the Central Agency Packaging Register. The label has already been vetted through its practical use and extensive trademark clearing to ensure that there are no conflicts with third party rights.

Who is already using the logos?

Major national and international brands use the waste sorting labels on their packaging, e.g.























Why integrate QR codes?

Younger customers in particular want digital educational offers: Over **50 percent of the younger target group** would like short explanatory films about correct waste separation that can be accessed via a QR code – in addition to the waste sorting labels.

What can the explanatory films behind the QR code do?


- The explanatory films are adapted to the target collection systems.
- The focus is on **sorting instructions** for consumers.

What happens when the QR code is scanned abroad?

- Through geo-localisation, a generic, English-language film is played outside Germany.
- Films can also be customised for specific countries.

Can the films be customised?

- Your own packaging examples can be integrated.
- Your own corporate design can be used.
- You can link to a specific landing page.

Distributors

- Applicable to all European waste collection systems
- Free use for producers who are registered with the Central Agency Packaging Register
- CI-compliant implementation possible and no costs for customization
- Flexible design options through optional use of text elements, QR codes and colours
- Space-saving application of the logo, text elements and QR code on packaging

Consumers

- Easy to understand thanks to clear visual language and symbols
- Less learning and interpretation effort thanks to uniform labelling
- Cross-manufacturer waste sorting labels **reduce complexity** from the consumer's point of view
- **Transparency** that the manufacturer assumes product responsibility for packaging
